EXECUTIVE SUMMARY

The Commission's Public Education activities for the year 2012 were based on two key focus areas, Constitution Awareness Creation and Deepening and Sustaining Civic Awareness.

Four key thematic areas namely, Public Education and Sensitization on the Principles and the Objectives of the 1992 Constitution, Voter Education of the Citizenry on Violent Free Elections, Youth and Public Policy in Ghana's Democracy through Project Citizen and Youth Sensitization on Civic Virtues were drawn out of the twelve policy objectives formulated to guide the Public Education activities for that year.

Awareness of Constitutional provisions among the youth was sustained in the year under review through the organization of the Constitution Game Competitions among Senior High Schools nationwide. Closely related to this was a special Project Citizen Showcase by three (3) selected Senior High Schools on using public policy to solve selected nagging community problems and the encouragement of the youth to "*Own their future*" by abstaining from drugs, substance abuse and trafficking at workshops and youth leadership camps.

It is worthy of note that the NCCE successfully and effectively collaborated with the Narcotics Control Board to educate the youth and also create awareness at the workshops on the dangers of drug use and substance abuse.

The year 2012 was undoubtedly significant in the political history of Ghana as the nation went to the polls for the sixth time under the 1992 Constitution breaking grounds with the use of the Biometric Voters Register. The NCCE undertook intensive and extensive education on the Biometric Voters Registration and observation of the elections in all existing constituencies.

The need for peaceful elections was crucial to the stability of the nation especially in 2012. As such, the NCCE intensified its education of the citizenry on violent Free Elections as well as formed Inter-Party Dialogue Committees comprising representatives of Political Parties and Civil Society to facilitate its efforts.

Another important activity was organization of workshops for Political Party Youth Activists on the need to refrain from violent acts before, during and beyond the elections. Added to this were Focus Group Discussions and Community Durbars on Non-Violence and full participation in the elections as well as post-election public education at the national and regional levels on sustainable peace.

The Commission did not overlook the important role of the Media in promoting and ensuring peaceful elections. Thus it organized five (5) Zonal Workshops for Media practitioners including Chief Executive Officers and Media owners on responsible reportage on election related activities for peaceful elections.

It is heart-warming to note that the Two Hundred and Thirty-five (235) participants pledged in a communique to be responsible in reporting on elections 2012 and beyond.

The twelfth Annual Constitution Week Celebration heralded the maiden National Democracy Lecture on “***Building a Peaceful, Democratic, Non-Partisan and Prosperous African State: Understanding Where African Leaders Have Gotten It wrong***”.

The celebration also introduced the Citizenship Day interactions with pupils in five hundred and seventy (570) basic schools at the National, Regional and District levels on responsible citizenship.

The NCCE boldly upheld the celebrated adage “***A Sound Mind in a Sound Body***” by organizing public education activities on prevention and control of Malaria, one of the nation’s killer diseases in one hundred and sixty (160) districts in partnership with the Ghana Health Service. The workshops among others promoted the use of treated bed nets and other prevention measures.

In the area of Research, the Commission carried out a very important survey on “***Issues of Concern to the Ghanaian Voter***”, to guide the electorate to vote responsibly on issues and also to inform the Political Parties on the areas of concern to the Ghanaian Voter.

The Commission also pursued a number of collaborative activities with its partners including the African Peer Mechanism Governing-Council, Centre for Democratic Development, International Labour Organization.

CHAPTER ONE

1.1 Introduction

The strategic direction and priorities of government in the medium-term as stated in the Ghana Shared Growth and Development Agenda (GSGDA) is to lay the foundation for the structural transformation of the Economy, through industrialization especially manufacturing, based on modernized agriculture and sustainable exploitation of Ghana's natural resources, particularly minerals, oil and gas. The process will be underpinned by rapid infrastructure and human development as well as the application of science and technology including information technology and innovation. The purpose of this Annual Progress Report (APR) is to highlight how the NCCE has been able to use its sector Monitoring and Evaluation Plan (M&E) plan to track progress of all its programmes and activities identified in its Sector Medium-Term Plan within the plan period.

1.1.1 Our Vision

The NCCE's vision is to be an effective independent governance institution delivering of civic education to all Ghanaians and working towards sustaining Ghana's democracy.

1.1.2 Our Mandate

The NCCE is mandated to create awareness and educate Ghanaians on the significance of the constitution, strengthen constitutional democracy and the awareness of civic rights and responsibilities in the country.

1.1.3 Our Values

We apply integrity in all our dealings. We are present in every district and community throughout Ghana. The laws of Ghana clothe us with independence in the performance of our work.

1.1.4 Objectives of the Commission

The objectives include:

- To develop awareness in the Ghanaian citizenry to appreciate the philosophical underpinnings of the 1992 Constitution and to make them informed, responsible and effective participants in nation-building and;
- To develop continuously and systematically, the Commission's human resource potential.

1.2 Status of Implementation of SMTDP

The NCCE's Medium Term Development Plan is a four year Development Plan which covers all programmes, projects and activities of Commission at the national, regional and district levels.

The operationalization of the NCCE's Medium Term Development Plan borders on strengthening and deepening democracy in Ghana. In line with its goal, the NCCE during the period under review organized a number of activities aimed at meeting the development objectives of the plan. The Commission also through its flagship programmes has undertaken several awareness and sensitization programmes which have improved the exercise of civic rights and responsibilities by the citizenry.

1.3 Purpose of the M&E for the period

The NCCE's M&E Plan for the period under review focused on assessing the achievement levels of programmes run during the period, identify constraints and failures in the programmes undertaken, identify appropriate interventions that will increase the effectiveness of the programmes of the Commission, as well as provide information for effective coordination at the national, regional and district levels.

1.3.1 Process Involved

In preparing the Annual Progress Report, the key processes adopted included collection of data from secondary sources, such as the Progress Reports from the District and Regional offices. After collection of data from the various sources, the data was collated, cleaned up and analysed.

Based on the output of the analysis, the report was prepared to reveal the programmes that were undertaken by the Commission towards the realization of the Commission's goals as well as the status of implementation of the NCCE's Medium Term Development Plan under the Ghana Shared Growth and Development Agenda (GSGDA, 2010 - 2013).

1.3.2 Difficulties Encountered

In the preparation of the Commission's Annual Progress Report, 2012, there were a number of challenges encountered, some of which were:

- ❖ Weak institutional co-ordination between the PME Department and some Departments especially with regard to timely submission of required data for to the former towards preparation of the APR.
- ❖ Inadequate institutional capacity in the area of logistics and human resource for the Data Collection, Collation, Cleaning and Analysis towards the preparation of the APR. A typical situation can be given on the inability of the Commission, acting through the Programme

Monitoring and Evaluation Directorate, to embark on monitoring exercise to confirm the status of implementation of the MTDP as per the report submitted to it by the Regional and District Offices.

- ❖ Ineffective M&E feedback mechanisms at the Commission.
- ❖ Exceptionally low or sometimes no budgetary allocation for M&E activities.

2.5 Update on Critical Developments

The Commission has over the years been involved in civic education of the citizenry on a variety of issues pertaining to national development. The update on the efforts of the Commission for the year under review has been stated below under various themes.

2.5.1 Public Education

The Commission undertook various public education campaigns with various partners under the year of review. Prominent among the educational activities were the Constitution Week Celebration prominent among which being institution of Annual Democracy Lecture and Citizenship Day. Other activities included voter education on Election 2012 and formation of Inter-Party Dialogue Committees to facilitate the process, Focus Group Discussions, Community Durbars and Workshops for Political Party Activists on Violent Free Election as well as sensitization of the Youth on the dangers of drug abuse and substance use.

2.5.2 Capacity Building

The NCCE as part of its effort to successfully implement the *Five-Year Enhanced Strategic Plan* organized a capacity building workshop for 110 Accounts staff towards Election 2012 at the Public Services Union Centre, Kumasi.

It also under the year of review granted 10 members of staff study leave with pay to pursue various courses in recognised higher institutions.

CHAPTER THREE

THE WAY FORWARD

3.1 KEY ISSUES ADDRESSED AND THOSE TO BE ADDRESSED

3.1.1 KEY ISSUES ADDRESSED

The Commission carried out a lot of activities aimed at giving further expression to its Constitutional mandate which includes creating and sustaining among the people of Ghana awareness on the principles and objectives of the 1992 Constitution.

Under the theme “*STAND UP FOR GHANA*”, the Commission earmarked and successfully executed the listed programmes and activities across the country during the year under review.

Key issues that were addressed included:

- Increased and effective participation in the electoral process
- Creating peaceful and congenial atmosphere before, during and beyond the 2012 general elections
- Promoting free, fair and transparent elections
- Enhancing sustainable peace and democratic governance
- Inculcating the virtues of good citizenship in pupils
- Promoting high standards in reporting amongst Media Personnel
- Encouraging the youth to stay away from drugs
- Increased knowledge of the Constitution among the youth

3.1.2 KEY ISSUES INTENDED TO BE ADDRESSED

The Commission, mindful of the importance of gender in the development of our nation, set up the Gender and Equality Desk to give prominence to gender related issues especially addressing gender and equality imbalance. The NCCE intends to celebrate the International Women’s Month nationwide to emphasize on the rights of women and other marginalized groups.

It also plans to mark International Day for the Protection of the Rights of Children and partner the ILO and appropriate Civil Society Organizations to undertake Child Rights education and to give voice to children. The programme will focus on childhood mortality, child labour, Female Genital Mutilation and other cultural practices which are inimical to the development of children.

To deepen and sustain Constitutional awareness, the NCCE will embark on intensive engagements with identifiable organizations on Directive Principles of State Policy to educate them on the obligations of the State to its citizen especially towards marginalized groups.

The Commission will expand the participation of basic schools in the celebration of Citizenship Day as well as the implementation of Project Citizen which currently stands at one hundred and ninety-five senior high schools to cover all schools at that level. This will encourage them to appreciate the fact that *everyone counts* in Ghana's democracy.

The NCCE will additionally intensify the dissemination of information on the roles of the three (3) arms of Government, the Executive, Judiciary and Legislature to deepen public knowledge of the workings of these state institutions.

The Commission plans to liaise with Security Agencies to sensitize the public on maintaining peace and stability in the country.

To strengthen the functional relationship between Assembly Members and Citizen and to deepen the knowledge on Citizen on Decentralization and Local Government in general, the Commission intends holding a series of media programmes and other public education activities to clarify the roles of District Chief Executives, District, Municipal and Metropolitan Assemblies and Members.

3.2 RECOMMENDATIONS

To enhance the performance of the Commission in terms of outputs and outcomes, the following recommendations are being made:

- Increased and timely release of budgetary allocations for effective and efficient planning and organization of programmes.
- Provision of vehicles and other means of transport for all the District Offices to enhance accessibility to every part of the country especially to the historically marginalized.
- Provision of Audio Visual Equipment to enhance education especially in communities without electricity.

3.3 CONCLUSION

The NCCE in the year 2012 made giant strides in implementation of its programmes to include breaking of new grounds for more effectiveness. The institution of the Democracy Lecture and Citizenship Day widened and intensified citizens' participation in Ghana's democracy including the youth.

The Commission's deep involvement in important activities pertaining to the electoral process and its activities encouraging political tolerance at all levels extensively contributed to the peaceful elections in the year under review. Other related activities and youth programmes further gave more meaning to the importance of civic education in democracy.

Successful implementation of programmes and activities outlined solely or in collaboration with its partners, went a long way to strengthen and deepen Ghana's democracy in line with the Commission's Medium Term Development Plan which borders on strengthening and deepening democracy in Ghana.
